Students who are:					
FULL TIME are expected to attend EDP every day, unless there are days not indicated as attendance days. Three days or more each week is considered full-time. Please let us know the days we should expect your child to attend on a regular basis by circling them below. (For example: if you only anticipate your child attending M-TH, do not circle F. This doesn't mean your child cannot attend on Fridays; it just means that we will not expect your child on Fridays, unless you tell us otherwise.)					
PART TIME are only expected to attend EDP one or two days each week, on a regular basis. If your child will attend the same days every week; you will only need to notify us of your child's schedule once, unless it changes. (For example: if you only need your child to stay every T & TH, just circle T & TH) Your child will remain eligible to attend EDP on days other than those you indicate below; however, we will only expect your child to attend EDP on the days you circle. (Please note: children attending three or more days per calendar week on a regular basis, are considered Full-Time.)					
<u>DROP-INS</u> are not expected to attend EDP unless we are <u>notified</u> of their need for attendance. If you need your child to drop-in to the program, please contact the EDP office as soon as possible to let us know when to expect your child. Please register your child at least one full school day prior to needing them to drop in.
