PART I. GENERAL EXPECTATIONS

Mission Statement: The mission of Homewood City Schools is to educate and empower all students to reach their unique potential.

Beliefs: We believe that...

- A free society demands individual and collective responsibility.
- Education is the most important responsibility of any society.
- Individuals are responsible for themselves and their actions.

- Optimal performance requires physical, intellectual, and emotional fitness.
- Growth is not possible without change; all people have the ability to effect change.

Homewood City Schools recognizes that parental involvement is key to academic achievement. The term "parent" refers to any caregiver/guardian who assumes responsibility for nurturing and caring for their children. When parents are involved in their children's education, the attitudes, behaviors, and achievements of students are positively enhanced.

Parents and families provide the primary educational environment for children. As such, parents are vital and necessary partners with the educational community throughout their children's school career. Although parents come to the schools with diverse cultural backgrounds, primary languages, and needs, all parents want the best for their children. Homewood City Schools, in collaboration with parents, teachers, students, administrators, and the community, has developed and promoted strategies that encourage parental involvement and reflect the needs of students, parents and their families.

It is the policy of the Homewood City School Board that no person in the district shall, on the basis of race, color, disability, creed, religion, sex, age, or national origin be denied the benefits of, or be subject to discrimination in any education program of activity.

In order to enhance parental involvement, six essential elements will be promoted:

1. Communication between home and school is regular, two-way, and meaningful.

- 2. Parenting skills are promoted and supported.
- 3. Parents play an integral role in assisting student learning.
- 4. Parents are welcomed as <u>volunteers</u> in the school, and their support and assistance are sought.
- Parents are full partners in <u>school decision making</u> that affects their children and families.
- 6. Parents, school and communities <u>collaborate</u> in order to strengthen the school, families, and student learning.

Providing all students with equal access to quality education is a primary goal. It is vital that all stakeholders (parents, educators, businesses and the community) have the opportunity to provide input and offer resources to meet this goal. Developing cooperative efforts and providing access to resources will ensure improved academic achievement for all students, as well as quality schools.

The minimum requirements for the Parent Involvement Plan are set forth below. These requirements are based upon the six essential elements for a successful program. Additional programs and services may be added based upon the needs of the schools, teachers, parents, and students. In order to have an effective program, all stakeholders (PTA, parents, administrator, teachers and community) must interact and form a partnership.

- 1. **Standard I: Communicating:** Effective communication requires school-initiated contact with the parent, and parent-initiated contact with the school, where both parties provide vital information about a child's strengths, challenges, needs and accomplishments.
- 2. **Standard II: Parenting:** Parents are their children's first and most influential teachers. During school years, children spend only one eighth of their time in school. Parents and caregivers spend more time with their children than any educator. Therefore, the influence parents have on their children's success in school and beyond are tremendous. School personnel and program staff shall support positive parenting by respecting and affirming the strengths and skills needed by parents to fulfill their role. Parents shall be linked to programs and resources within the community that provide needed support services.
- 3. **Standard III: Student Learning:** Parents play an integral role in assisting student learning. Student achievement increases when parents are actively involved in the learning process. Homewood City Schools shall provide opportunities for parents to learn effective ways to support their child's educational needs. This includes information about how parents can support positive student behaviors such as punctuality and regular attendance, which are closely tied to student success in school.
- 4. **Standard IV: Volunteering**: Parent volunteers are essential for advancing student achievement. Homewood City Schools welcome parent volunteers and invite them to be part of their children's education.

- 5. **Standard V: School Decision Making and Advocacy:** Parents are full partners in the decisions that affect their children and families. Parents and educators have a mutual responsibility to make informed decisions related to all aspects of the education provided to our students. Homewood City Schools shall actively enlist parent participation in decision-making. An annual evaluation will be conducted to determine the effectiveness of parental involvement activities and to identify barriers to greater participation by parents. The results of the evaluation will be utilized to develop more effective strategies and to revise the plan. The district's committee for Student Assistance Planning (SAP) will assist in evaluating the effectiveness of school plans.
- 6. **Standard VI: Collaborating with Community:** Homewood City Schools' parents, educators, and community members will work together in order to promote and effectively increase educational opportunities for children. Through groups such as the Education Advisory Committee, Title I parent Involvement Committee, Homewood City Schools Foundation, the Safe and Healthy Homewood Coalition, and local school Parent Teacher Student Associations, programs will be discussed and reviewed. When schools and communities form partnerships, both make gains that outpace what either entity could accomplish on its own.

- 4. <u>Homewood City Schools</u> will coordinate and integrate parental involvement strategies in Part A with parental involvement strategies under the following other programs:
 - Coordination and parental programming associated with Homewood's pre-school program located at Hall-Kent
 - Ongoing contact and communication with local preschool programs
 - Communication and participation with local English language development programs and ministries
- 5. Homewood City Schools _ will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement plan in improving the quality of its Title I, Part A schools. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background). The school district will use the findings of the evaluation about its parental involvement plan and activities to design strategies for more effective parental involvement and to revise, if necessary (and with the involvement of parents) its parental involvement policies.
 - Survey evaluations will be emailed out to parents of students in participating Title I programs
 - Parents are asked open-ended questions concerning their communication with school personnel, their satisfaction with Title I programming, and their suggestions for parental programming for the future.
 - Surveys are reviewed by the district federal programs director, who will communicate
 feedback to appropriate school personnel as well as incorporate ideas into plans for the
 coming year.

<u>Homewood City Schools</u> will build the schools' and parent's capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, through the following activities specifically described below:

- A. The school district will, with the assistance of its Title I, Part A schools, provide assistance to parents of children served by the school district or school, as appropriate, in understanding topics such as the following, by undertaking the actions described in this paragraph --
 - the State's academic content standards,
 - the State's student academic achievement standards,

Activities to support the above objectives include:

- Regularly scheduled monthly PTO and Parental Involvement Committee Meetings
- Weekly home-to-school communications
- Fall/Spring Title I meetings, held at various times throughout the day

- Website/email communication
- Translated communication (one-on-one & printed materials)
- Presentations & discussions at Board Meetings, PTO meetings; and Educational Advisory Meetings (EAC)
- School orientations
- Conference opportunities
- B. The school district will, with the assistance of its schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training, and using technology, as appropriate, to foster parental involvement, by:

Activities to support the above objectives include:

- Consultations with school guidance counselors
- Consultations with district Behavioral Interventionist (LSW)
- Strengthening Families Program provided by school district and Impact Family Counseling
- Peer Helpers Program
- Planned programming in Title I meetings
- Group counseling services provided by Impact Family Counseling
- C. The school district will, with the assistance of its schools and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

Activities to support the above objectives include:

- Safe and Healthy Homewood Coalition (provides data, information, and training to parents and community members concerning preventative behavioral measures (underage alcohol use; tobacco use; marijuana/drug use)
- Services with Impact Family Counseling, including group counseling for students and participation by entire families in the scientifically researched-based *Strengthening Families Program*.
- Monthly professional development sessions for guidance counselors only.
 Topics have included suicide, communicating culturally with diverse families, and grief counseling
- Teen Driving program a local psychologist conducted a program with parents concerning safety
- Awareness bulletins related to drug and alcohol use
- An "After the Game Party" conducted at a local church to encourage students and families to participate in "safe" activities after a football game
- Game night Title Programs have conducted a "game night" where students played academic literacy games with their parents or otherwise utilize technology
- Wellness Plan & Programming the district has developed a wellness plan
 that has stretched involvement out of the schools and into community actions
 (more exercise programs; community race established). Parents have been a
 large part of this process
- School-wide Math Night in the winter

- D. The school district will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:
 - Homewood has a structured tiered intervention reading and math program in all 5 schools to assist students/families with reading and math difficulties
 - The elementary "Extended Day" programs offer tutorials and study halls in the afternoons for students who participate in that program.
 - The PTOS and schools share information back-and-forth between the schools and the community
 - Homewood Schools has a pre-school program located at Hall-Kent for special needs students that also maintains openings for positive peer role models
- E. The school district will take the following actions to ensure that information related to the school and parent- programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
 - Weekly/Monthly communications from various schools. Elementary schools maintain a steady system ("Friday Folder, Tuesday Communicator") to assist parents with communications from the school and community
 - Parents have options to receive information electronically or in print versions
 - Communications can be sent home in multiple languages
 - School/District website, including a section specifically for parent communications
 - The system has an online grade book programming that allows parents to see posted grades in real-time
 - Translators are provided at all conferences and title I meetings
 - Title I parents participate in a yearly survey that provides an opportunity to communicate ineffective practices

- Schools have parental involvement committees which evaluate and sponsor different activities and programming for parents
